



Place A Plaque

A plaque is a poignant tribute and lasting symbol of remembrance to a loved one or dear pet.

We have a number of options

Option 1 - Honed Slate Plaque - 150mm x150mm with a maximum of 5 words fixed to the outside of the building (£90)

Option 2 - Honed Slate Plaque - 225mm x 225mm with a maximum of 10 words fixed to the outside of the building (£150)

Option 3 - Green Acrylic Plaque fixed to the fencing of an outside run (Joint sponsorship £500 per sponsor)

Option 4 - Green Acrylic Plaque fixed to the fencing of an outside run (Sole sponsorship £1000)

Option 5 - Stainless Steel Plaque fixed to the kennel door (Joint sponsorship £3000 per sponsor)

Option 6 - Stainless Steel Plaque fixed to the kennel door (Sole sponsorship £6000)
